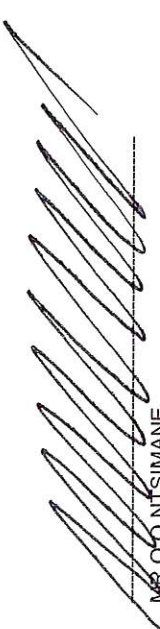
No late bids will be accepted.
